

## Message of support from 25,000 U.S. longshore workers to the people of Costa Rica, and Limón and Moín:

For some time, workers in the SINTRAJAP port workers union have been under an unfair, illegal attack by the Costa Rican government. They have offered SINTRAJAP leaders huge payouts to give up their union so the ports can be privatized. But SINTRAJAP refuses to betray their community. They are holding firm because they are concerned not only how this attack will affect their own families, but also their neighbors and paisanos. <u>You have a right to know</u> what's at stake before it's too late:

## Foreign capital should not be allowed to take control of Costa Rican exports

The forced privatization of the Ports of Limón and Moín means that the people of Costa Rica will lose the rights to national property. If SINTRAJAP is defeated, multinational corporations will be in charge of Costa Rica's imports and exports. SINTRAJAP wants to work with JAPDEVA to modernize Costa Rican ports for the betterment of all Costa Rican people – not foreign entities.

## Democracy must be protected from underhanded attacks

If the Costa Rican government gets away with illegally replacing the workers' elected leaders on the docks, they could do it anywhere. SINTRAJAP's democratically elected General Secretary, Ronaldo Blear, was replaced in a sham election forced by the Costa Rican government, by a vote of only 345 of 1500 members present. That is not a majority! Workers voted to reaffirm him soon thereafter, but the government remains in defiance of international labor law. They have taken away the union's access to its bank accounts and started shutting down their union office. This attack on democracy is not something a Nobel Prize-winning president should allow. If it happens to SINTRAJAP, it can happen to anyone!

## JAPDEVA funding for schools and services should continue to benefit everybody

In Limón and Moín, many people rely on JAPDEVA funds to build good schools and important services for local families. There's no reason to change the way things have worked for local communities for this long. SINTRAJAP is fighting to protect JAPDEVA funding for everyone.


